The meeting of the West Caln Township Board of Supervisors was held on Monday February 8<sup>th</sup>, 2016 at 7:00 PM in the Township Municipal Building. In attendance were Chairman Pfitzenmeyer, Vice-Chairman Martz, Supervisor Martin and Assistant Manager/Acting Secretary Russell. There were 22 citizens present.

Chairman Pfitzenmeyer opened the meeting at 7:00 PM by leading the pledge of allegiance and the following business was then conducted:

#### A. Citizen Comments

- a. Comment was to thank the road crew for their great job during the latest storm
- b. Comment was to thank for the name plates for the supervisors
- c. Question: what is happening at the Junkyard on Telegraph Road? Chairman Pfitzenmeyer stated that they have been working with the junk yards, having meetings and moving forward
- d. Question: what is happening with the bridge in Wagontown? Police Chief Martinez stated they are stabilizing and securing it
- e. Mr. Slaymaker asked why the meetings are not videoed and placed on the website for all to view? Chairman Pfitzenmeyer stated that the Township will look into this.

#### B. MS 4

Mr. Dan Daley from EB Walsh presented information as to the MS4 requirements. He has been working on the townships stormwater and has submitted a permit to the DEP. Currently the Township has a TMDL plan to improve the water quality in our township. The reason for the presentation is to open it up for questions in regards to the intended projects that we can do to improve the water quality in our area.
