# 4. CITIZEN'S COMMENTS

- a. Marian Hilton of 2128 Compass Road, Martin Stern of 3111 Compass Road, and Joe Miller of 3125 Compass Road all spoke about the buzzard problem in their area and specifically on their properties. Ms. Hilton is hearing impaired and her daughter, Karen Senior, spoke on her behalf. Details regarding extent of the buzzard population, the damage occurring, the original cause of the problem, solutions already attempted, and possible solutions to try were discussed. The Supervisors were in agreement that this is a serious issue, however legal solutions are limited. Manager Siedenbuehl will contact the Chester county Health Department and Chief Martinez will contact the PA Game Commission to see if either of these agencies can help.
- b. Marian Hilton also wanted to bring to the Supervisors' attention that the privacy fence between her property and Solomon Zook's property is in disrepair and falling over. She has submitted an official complaint which includes images of the fence condition. Concern was also voiced over the size of business and if it is in compliance with the variance that he was originally granted. The Supervisors and Manager will review the property.
