**Board of Supervisors** 



A regular monthly meeting of the West Caln Township Board of Supervisors was held on Wednesday, August 23, 2017 at 7:00 P.M. in the Township Municipal Building.

- 1. Supervisor Pfitzenmeyer opened the meeting 7:01 PM and led in the salute to the flag.
- 2. An Executive Meeting will be held after this evening's BOS meeting for personnel reasons.

## 3. CITIZEN'S COMMENTS

Four residents came before the BOS with the same concerns. Mr. Shesko spoke for the group and informed the BOS of ongoing neighborhood concerns with 154 Oak Lane. He described periods of constant gun fire, gun fire into open and wooded areas, and heavy 4-wheeler traffic on the roadway. Residents of the area are fearful for their safety during these activities, which occur most weekends. Mr. Shesko inquired if there are Township Ordinances that regulate gun use that can be enforced. Ms. Sebastian added that there is often consumption of alcohol occurring during these activities. She also stated that the noise, fuel fumes, and a fear for safety have driven her from her home at times. Mr. Tapia added that they can't allow their children to be outside during these times. A general conversation followed between the residents, the BOS, and Chief Martinez. It was stated the property owner does reside on the premise and that the property is known to be occupied by the owner's son. Residents stated that attempts have been made to discuss the issue with the current occupant of 154 Oak Lane, with no positive response.

Chief Martinez stated that he has spoken with the occupant in the past. Chief Martinez advised the residents to call 911 as soon as the activities begin, so that police can arrive at the scene while the activities are occurring. Chief Martinez updated the BOS and residents as to what has been done to this point in conjunction with other agencies. The Hibernia Park Rangers have been called and have done some investigation, as much of the gunfire is directed into the Park. Chief Martinez and the BOS discussed which agencies can be notified to enforce existing laws and regulations. Chairman Pfitzenmeyer instructed Manager Siedenbuehl to confer with Solicitor Venzie with regard to legal actions that can be taken against the property. Chairman Pfitzenmeyer asked the residents if they would be willing to testify in court regarding these issues if it became necessary. They all responded that they would. The Chief and the BOS stated that they will be investigating this matter and taking whatever steps are necessary to resolve the issues at hand.

  Walsh Associates, Inc. Public notice was given in the Daily Local News as follows:

West Caln Township has developed these plans in order to meet the requirements of their upcoming National Pollutant Discharge Elimination System (NPDES) Individual Permit to Discharge Stormwater From Small Municipal Separate Storm Sewer Systems (MS4s) Application. All comments shall be submitted in writing to the Township prior to August 31, 2017 was given and the Plan is available for review and comment in the Township Office until August 31, 2017.

Mr. Daley presented a summary of the Plan. He then opened the presentation to questions from the Board of Supervisors. Supervisor Martz asked for clarification about retro-fitting basins. Mr. Daley provided a concise explanation. Mr. Daley then opened the presentation to questions from residents.
