

A regular monthly meeting of the West Caln Township Board of Supervisors was held on Wednesday, October 11, 2017 at 7:00 P.M. in the Township Municipal Building.

Supervisor Pfitzenmeyer opened the meeting at 7:08 PM and led in the salute to the flag.

- 1. CITIZEN'S COMMENTS
 - a. Brian Horblinski, of 143 Martins Corner Road, presented his request for a 8'x8' prebuilt shed on his property. His property is zoned AP, and therefore cannot have an accessory structure as a use-by-right. The Board of Supervisors just discussed this issue as related to another property zoned AP and had determined that they will allow the shed and will find a legal path to do so. After a brief discussion with Solicitor Venzie, the Board indicated to Mr. Horblinski that the same will apply to his situation. He was given permission to proceed with his Zoning Permit for a shed on his property.
 - b. Jessica Rigo presented the Board of Supervisors with a check for \$500.00 from the Chester County Marathon. She thanked them for their support and requested to arrange with Parks & Recreation to hold the same event next year on June 3, 2018. Chairman Pfitzenmeyer indicated that Ms. Rigo can coordinate with the Parks & Recreation Commission on plans for 2018.

6. POLICE REPORT

The Board of Supervisors accepts the Police Report as presented.

- a. Chief Martinez read out Ashley Bosch's letter of resignation. Chairman Pfitzenmeyer made a motion that the Board of Supervisors write Office Bosch a letter of commendation and thanks for her service to the Township.

- b. Chief Martinez read out a letter from Patriotic Order Sons of America requesting the placement of one of their collection receptacles for used American flags so they may be properly retired. Earl Fryberger, a representative from the organization was present and provided more information and answered questions from the Board of Supervisors. Chairman Pfitzenmeyer moved that West Caln Township allow the placement of this box in the Township Building.

- c. Chief Martinez announced that Pete Mango is collecting donations to send to his son's paratrooper unit currently serving overseas. Chief Martinez requested that the Township serve as a collection spot for these donations. Supervisor Martz made a motion to approve this.

- d. Chief Martinez indicated that he has received calls expressing concern for the safety of walkers/runners along Wagontown road due to the overgrowth of trees and brush along the road. He is requesting signage warning of pedestrians and pedestrian crossings. Chairman Pfitzenmeyer instructed Chief Martinez to connect with Road Foreman Touchton to discuss and arrange signage.
- e. Chief Martinez issued a warning to the Township to be aware that wild or feral animals carry the risk of rabies and to proceed with caution when dealing with them. Chief Martinez and a township resident were recently in contact with a feral cat that tested positive for rabies. Both the Chief and the resident are undergoing preventative rabies treatment at this time.

 - The Applicant shall pay all consultant fees incurred by the Township in connection with the Final Plan which remain unpaid.

Motion to approve waivers from Section 505.b, Section 511, Section 516 and Section 525 of the SALDO shall be granted provided that all comments in the Township Engineer's review letter dated October 5, 2017 be resolved, including those items specifically outlined in the concluding paragraph of said letter.

 Motion to approve the final, minor subdivision plan for the County of Chester dated September 8, 2017 for a lot line adjustment, subject to completion of any unresolved items outlined in the Township Engineer's review letter dated October 5, 2017.

As recommended by the Township Engineer, a motion to grant a waiver from Section 525 (installation of street trees) and a waiver from the requirements to submit the following:

- A final erosion and sediment control plan
- A final stormwater management plan
- A final landscape plan

- i. Supervisor Martz mentioned an article he recently read in a PSATS publication regarding tax relief for volunteer fire fighters in PA. A general discussion followed, with John Sly offering quite of bit of information. The tax relief is for a portion of the township property tax only. Solicitor Venzie noted that many townships have indicated thoughts to participate but the complications to administrate the program are significant.
- j. Supervisor Martin reported on the status of aging trees on various Township properties. Will's Property Service has provided an estimate of \$2490.00 to complete all the removal, trimming, etc. that needs to be done. A motion was made to accept the proposal.
