

A regular monthly meeting of the West Caln Township Board of Supervisors was held on Wednesday, May 9, 2018 at 7:00 PM in the Township Municipal Building.

Supervisor Martin opened the meeting at 7:00 PM and lead in the salute to the flag.

1. EXECUTIVE SESSION

An executive session was held on Wednesday, May 2, 2018 for legal and personnel reasons.

2. CITIZEN'S COMMENTS

- A. Lewis Singer, 102 Northwood Drive, inquired about the status of enforcement of the Grumbine property. Manager Siedenbuehl reported that the attorneys for the property owner and the township are continuing to work toward an agreement.
- B. Roxanne Singer, regarding the Grumbine property, stated that her concern is for her well and possible contamination from gasoline and oil.
- C. Clair Pyle, 191 Sugarman Road, stated his thoughts on the recent Coatesville Area School District town hall meetings and the proposed school tax increase. He asked if the Board of Supervisors would write a letter on behalf of West Caln Township to the School Board opposing this proposed increase. Supervisor Hutton and Treasurer Barsz each responded informing Mr. Pyle and the others in attendance of more effective avenues for the residents to make their opinion on the proposed tax increase known.
- D. Hardin Ervin, 203 Pine Valley Drive, spoke regarding the use of the Land Preserve across from Layton Park for dogs both on and off leash. A discussion followed regarding his wife's experience with her dog at the park, the regulation differences between Layton Park and the Land Preserve, and the planned signage for that area. Signs will be hung at the Land Preserve that dogs are allowed off-leash but they must be under the control of the owner, and all risk is assumed by the pet owner. Layton Park rules remain unchanged; all dogs must be on a leash at all times. Owners of dogs who run across the road from the open space to the park will be subject to citation.
- E. Brian Bensinger, 279 Martins Corner Road, asked for an update with regard to his complaint about Turpin Landscaping. No update was available, and Manager Siedenbuehl will contact Mr. Bensinger once there are findings regarding his complaint.
- F. Michelle Powell, 1470 Airport Road, stated her complaint regarding the property at 1466 Airport Road. The property is a rental and they have not had success reaching the owner regarding the trash on the property. The Board asked Ms. Powell to submit and official complaint form, with pictures if possible, to the Township office for review.
