4. US EPA Presentation

Timothy Gallagher, P.E., Eastern PA Remedial Branch Project Manager was present to provide the Board with an update on West Caln Superfund Sites. Approximately 99% of all contaminants have been cleaned. The EPA will be discussing the possibility of connecting to public water with the residence on Toby Road sometime in the next year or so. Any plans for this possible connection would be presented for public review and the whole process could take a year or more.


